






















AVERAGE ECONOMIC GROWTH BY STATE

ANNUAL PERCENTAGE CHANGE - AVERAGE AS OF Q2 2024 SEASONALLY ADJUSTED SERIES




ECONOMIC ACTIVITY IN CHIHUAHUA









Based on the Federal Secretary of Economy data, Mexico registered 35.7 billion dollars in Foreign Direct Investment (FDI) as of the first quarter of 2024.

During the same period, Chihuahua received 1,250.2 million dollars, contributing 3.5% of the national total, and the state is ranked 6th as the recipient of FDI after Mexico City, Mexico State, Baja California, Guanajuato & Nuevo Leon .



































